The "Rates" to be charged by Franchisee shall be established by the Chester Public Utility District Board, in accordance with this Agreement and as set out in the rate schedule above.

The initial Rates set forth above, and all rates established by the Chester Public Utility District Board, shall be subject to annual increases as follows:

- Annual CPI/Fuel Adjustments
 - 75% based on the percentage of change in the Consumer Price Index, All Urban Consumers, U.S. City Average-Item: Garbage and Trash Collection (1983-100) (CPI) (Series ID: CUSR0000SEH02) as published by the Bureau of Labor Statistics, Washington, D.C.
 - 25% based on the percentage of change in the Fuel Index, All Urban Consumers, West Urban-Item: Motor fuel (1982-84=100) (Series ID: CWUR0400SETB, WUS0400SETB) as published by the Bureau of Labor Statistics, Washington, D.C.
 - The first adjustment shall be made effective as of July 1, 2021, and shall be based on the annual average CPI and Fuel increase for the 12-month periods ending December 2020 compared to December 2019, and Rates shall be adjusted in the same manner annually thereafter.
 - Adjustments in accordance with the CPI and Fuel index shall not be less than 0% or be greater than 6% in any one year regardless of the percentage increase to the CPI and Fuel index. Any increase to franchise fees will not be considered against the 6% cap.
- In addition to CPI/Fuel Adjustments described above, Franchisee's Rates shall be adjusted to capture increased costs resulting from circumstances beyond Franchisee's reasonable control, including increases in disposal fees at the County Transfer Station, increases in processing fees at third party facilities, new or increased taxes, fees, or other governmental charges, changes in Applicable Law (including SB 1383), and force majeure events.

EXHIBIT B

RECYCLABLE MATERIALS SPECIFICATIONS

RECYCLABLE MATERIALS must be dry, loose (not bagged) and include **ONLY** the following:

Aluminum cans – empty	Newspaper
PET bottles with the symbol #1 – with screw tops only – empty	Mail
HDPE plastic bottles with the symbol #2 (milk, water bottles detergent, and shampoo bottles, etc.) – empty	Uncoated paperboard (ex. cereal boxes; food and snack boxes)
	Uncoated printing, writing and office paper
Steel and tin cans – empty	Old corrugated containers/cardboard (uncoated)
Glass food and beverage containers – brown, clear, or green – empty*	Magazines, glossy inserts and pamphlets

NON-RECYCLABLE MATERIALS include, but are not limited to the following:

Plastic bags and bagged materials (even if containing Recyclable Materials)	Microwavable trays
Mirrors	Window or auto glass
Light bulbs	Coated cardboard
Porcelain and ceramics	Plastics not listed above including but not limited to those with symbols #3*, #4*, #5*, #6*, #7* and unnumbered
Expanded polystyrene	Coat hangers

Hoses, cords, wires	Yard waste, construction debris, and wood

ADDITIONAL SPECIFICATIONS:

Contained materials may not have more than 10% Non-Recyclable Materials or any Excluded Materials. Carts or Bins with more than 10% Non-Recyclable Materials may be delivered to the designated transfer or disposal facility for disposal. "Excluded Materials" means radioactive,

volatile, corrosive, flammable, explosive, biomedical, infectious, bio-hazardous or toxic substance or material, or regulated medical or hazardous waste as defined by, characterized or listed under applicable federal, state, or local laws or regulations, materials containing information (in hard copy or electronic format, or otherwise) which information is protected or regulated under any local, state or federal privacy or data security laws, including, but not limited to the Health Insurance Portability and Accountability Act of 1996, as amended, or other regulations or ordinances.

Franchisee reserves the right, upon notice to District, to reclassify Recyclable Materials as Non-Recyclable Materials for such period of time that the cost process, transport and market such materials exceeds its then-current value.
