- **1. Call to Order:** Director Voboril called the meeting to order at 5:30pm.
 - a. Director Voboril led the Pledge of Allegiance.
 - b. Director Voboril acknowledged all board members in attendance confirming quorum.
 - c. Agenda Approval: Director Graffweg made a motion to accept the agenda as presented. Director Raker seconded. All in favor, motion carried.

2. Award Presentation: Eddie Mata

Chief Balzarini introduced Captain Matthew House to present the award. Captain House explained that while on shift, the on-duty ambulance crew were called to respond to a cardiac emergency at the Timber House Restaurant on June 22, 2023. Eddie Mata while he was on shift that day at the restaurant, administered CPR to the patient until the ambulance arrived. Mr. Mata is recognized for his courage, for reacting so quickly. Because of his swift actions, the patient's pulse was regained, and he was eventually breathing on his own. Only 10% of people survive a heart attack per the American Heart Association. Mr. Mata accepted the award and was thanked by the Captain, the Chief and The Board members. Many applauses then photos were taken.

5. September 2023 Financials: GM Cox presented:

- Less than 400K in checking.
- Auditor will clear out receivables that we will never receive from 2017-2019 CFAA agreement.
 After a brief discussion, Director Raker made a motion to approve the Financials. Director Tharpe seconded the motion.

6. General Manager's Report: by Adam Cox

All in favor, motion carried.

- Mostly been dealing with Fire Department Issues: Plans, Funding, Needs, Personnel issues, lawsuits, PRAs, and Disciplinary issues have taken the bulk of time.
- 3 more claims against the department, not lawsuits yet.
- The new liability insurance states we have to pay the first 25k for each of the lawsuits, which will be 125k, unbudgeted.
- Previous management left the district without liability insurance for 6 months. Now instead of 21K in premiums, we pay 100K+.
- We were sued by 2 employees of which we settled out of court. We started an internal investigation, but then all involved and listed within the suit left our employ.
- The finalized lawsuit is now public document.

7. Fire Chief Report: by Matthew Balzarini (Exhibit A Power Point)

- An over an hour detailed review of the last year was given. See attached Power Point.
- A public member stated that he wished the community would have supported this chief, now knowing what he dealt with.

Recess was taken at 6:55pm. Reconvened at 7:03pm.

• A public member stated that he was on the board, and that they only knew what management told them. He hopes the community supports the fire department; they need to.

The Local's Secretary, Lane Gomes, as well as the majority of the bargaining unit gave statements in full support of Chief Balzarini and his supervisory decisions. They also stated that the Local's President has used their voices at meeting, in letters and in phone representation without their knowledge. The Local's President's opinion is not shared by the majority. They stated that the antics noted in the Chief's report, committed by previous employees, are appalling and not how fire fighters normally behave. They assured the board and the community members in attendance that that would not happen again and apologized on behalf of the department.
